



## Codebook for Comprehensive Smokefree Air Rubric

2024

This codebook provides explanatory information about the questions, response options, scores, and scoring criteria in the [Comprehensive Smokefree Air Rubric](#) so that PETS users can better understand how the rubric provides the rationale for analyzing and grading California’s local tobacco prevention policies.

The Coder Instructions below provide an overview of the rigorous analysis guidelines used by PETS analysts to inform the analysis and scoring of every tobacco prevention policy against each rubric question.

### Scoring Criteria

The [Comprehensive Smokefree Air \(SHS\) Rubric](#) questions, response options, scores, and scoring criteria were developed and reviewed by tobacco prevention policy experts at ANRF in consultation with CTPP and the PETS Advisory Committee, including attorneys with expertise in local tobacco prevention policy language. Model policy language referenced in the development of the Comprehensive Smokefree Air (SHS) Rubric is from The Law and Policy Partnership to End the Commercial Tobacco Epidemic's [Smoke- And Tobacco-Free Outdoor Areas Model Ordinance](#) (2021), the Americans for Nonsmokers’ Rights [Model Ordinance Prohibiting Smoking in Outdoor Places of Employment and Public Places](#) (2018), and ChangeLab Solutions’ [Model California Ordinance Regulating Smoking \(and Tobacco Use\) in Indoor and Outdoor Areas](#) (2018).

Rubric language that is crossed out (e.g. Q30) indicates that PETS analysis is temporarily not being done on these questions and thus data is not yet available for these fields. PETS will resume analysis and data collection on these questions at a future date.

<b>Item</b>	<b>1. Does the policy apply to all inhaled tobacco and nicotine products (i.e. products that produce emissions) at least to the same degree that it applies to smoking?</b>

<b>Coder instructions</b>	<p><b>Yes</b> = The policy applies equally to all inhaled tobacco and nicotine products.</p> <p><b>No</b> = The policy does not apply equally to all inhaled tobacco and nicotine products.</p> <p><b>Note:</b> This question captures whether the policy’s smokefree air regulations apply equally to all products that produce emissions, including combustible tobacco products (e.g. cigarettes, cigars, little cigars/cigarillos, hookah/shisha) as well as heated products (IQOS) and vaped products (electronic smoking devices).</p>

<b>Coder instructions</b>	<p><b>Yes</b> = The policy explicitly prohibits the use of ESDs in ESD specialty businesses, regardless of whether smoking is regulated by the policy.</p> <p><b>Not Specified</b> = The policy does not specify whether the use of ESDs is restricted in ESD specialty businesses.</p> <p><b>No</b> = The policy does not prohibit the use of ESDs in ESD specialty businesses.</p> <p><b>Note:</b> ESD businesses include vape shops, vaping lounges, and other specialty retailers.</p>

<b>Coder instructions</b>	<p><b>Yes, in all areas where smoking is prohibited</b> = The policy prohibits the use of smokeless tobacco in the same manner/in the same areas where smoking is prohibited.</p> <p><b>Yes, only in some/specified venues</b> = The policy prohibits the use of smokeless tobacco in the same manner/in the same areas where smoking is prohibited, except that use is permitted in some venues or in specified venues.</p> <p><b>Yes, but smokeless products permitted in specialty retailers and/or lounges</b> = The policy prohibits the use of smokeless tobacco in the same manner/in the same areas where smoking is prohibited, except that the use of smokeless tobacco, unlike smoking generally, is permitted in specialty retailers and/or lounges.</p> <p><b>Yes, Other</b> = The policy permits the use of smokeless tobacco generally, or smokeless products such as chew, snuff, etc. specifically, in venues other than, or in addition to, specialty retailers and/or lounges, where smoking of tobacco is prohibited in those venues.</p> <p><b>No</b> = The policy restricts the use of smokeless tobacco to a lesser degree than smoking, or it does not restrict the use of smokeless tobacco at all.</p> <p><b>Note:</b> This question captures specifically whether the policy’s smokefree air regulations apply to the use of smokeless/noncombustible tobacco products (other than heated tobacco). <b>Coder instructions</b>	<p>If <b>Q3 = Yes, Other</b>, list all venues in which the use of smokeless tobacco is permitted, other than, or in addition to specialty businesses (include specialty businesses in the list if applicable).</p> <p><b>Note:</b> This field should only be filled in if the permission to use smokeless tobacco in such venues is unique to smokeless tobacco use and does not also extend to smoking of tobacco in those venues.</p>

<b>Item</b>	<b>4. Does the policy apply to hookah/shisha products?</b>

<b>Coder instructions</b>	<p><b>Yes, in all areas where smoking is prohibited</b> = The policy prohibits the use of hookah/shisha in the same manner/in the same areas where smoking is prohibited.</p> <p><b>Yes, but permitted in specialty retailers and/or lounges</b> = The policy prohibits the use of hookah/shisha in the same manner/in the same areas where smoking is prohibited, except that the use of hookah/shisha, unlike smoking generally, is permitted in specialty retailers and/or lounges.</p> <p><b>Other/No</b>=The policy does not specifically permit the use of hookah/shisha in a venue where smoking is prohibited, or the policy permits use of hookah/shisha in a venue other than retailers/lounges (e.g. restaurants where smoking is otherwise prohibited).</p> <p><b>Note:</b> This question captures specifically whether the policy’s smokefree air regulations apply to the use of hookah/shisha. The policy must explicitly mention hookah, shisha, or water pipes.</p>

<b>Coder instructions</b>	<p><b>Yes, in all areas where smoking is prohibited</b> = The policy prohibits the use of heated tobacco products in the same manner/in the same areas where smoking is prohibited.</p> <p><b>Yes, but permitted in specialty retailers and/or lounges</b> = The policy prohibits the use of heated tobacco products in the same manner/in the same areas where smoking is prohibited, except that the use of heated tobacco products, unlike smoking generally, is permitted in specialty retailers and/or lounges.</p> <p><b>Other/No</b> = The policy does not use “heated” terminology, or use of heated tobacco (or all non-combustible tobacco use) is restricted to a lesser degree than smoking generally.</p> <p><b>Note:</b> This question captures specifically whether the policy’s smokefree air regulations apply to the use of heated tobacco products. These products are sometimes marketed as “heat-not-burn” and IQOS is the primary current example of a heated product. Policies already frequently define tobacco/smoking to include these products, de facto, possibly because, while recently approved, they have been in development for many years.</p>

<b>Coder instructions</b>	<p><b>Yes, both smoking <i>and</i> vaping marijuana in all areas where smoking is prohibited</b> = The policy restricts both smoking and vaping marijuana to the same degree as smoking generally.</p> <p><b>Yes, smoking <i>or</i> vaping marijuana in all areas where smoking is prohibited</b> = The policy restricts either smoking <i>or</i> vaping marijuana, but not both, to the same degree as smoking generally.</p> <p><b>Yes, but smoking and/or vaping marijuana permitted in marijuana businesses</b> = The policy specifically permits smoking and/or vaping marijuana in marijuana businesses.</p> <p><b>Other/No</b> = The policy restricts smoking and/or vaping marijuana in some manner, but to a lesser degree than smoking generally.</p> <p><b>Note:</b> This question addresses the smoking and/or vaping of <b>both</b> recreational/adult-use and medical marijuana. See Q6 sub-questions for more differentiation.</p>

<b>Item</b>	<b>6b. Are the marijuana restrictions free of exemptions for ESD-only marijuana use?</b>

<b>Coder instructions</b>	<p><b>Yes</b> = The policy does not contain any exemptions for vaping marijuana.</p> <p><b>No</b> = The policy contains specific exemptions for vaping marijuana.</p>

<b>Coder instructions</b>	<p><b>Yes</b> = The policy specifically exempts smoking or vaping marijuana from the policy's smoking prohibitions.</p> <p><b>No</b> = The policy does not specifically exempt smoking or vaping marijuana, or it exempts it in specific venues.</p>

<b>Item</b>	<b>7. Is the policy free of an exemption for marijuana special events?</b>

<b>Item</b>	<b>8. Does policy require all outdoor public places generally to be smokefree?</b>

<b>Coder instructions</b>	<p><b>Yes</b> = The policy specifies that all outdoor public places in the jurisdiction must be 100% smokefree.</p> <p><b>Limited Smoking Areas</b> = The policy specifies that all outdoor public places in the jurisdiction must be smokefree, except for a very narrow circumstance (e.g. by application for a smoking section, or a limited number of smokers' outposts in the jurisdiction). This option is uncommon. If this option is selected, specify the requirements in Q8a.</p> <p><b>Sections</b> = The policy specifies that all outdoor public places must be smokefree, except for designated smoking areas, unless otherwise exempt.</p> <p><b>No</b> = The policy does not specify that all outdoor public places must be 100% smokefree unless otherwise exempt. Only public outdoor places specifically mentioned in the policy are required to be smokefree.</p> <p><b>Note:</b> It is uncommon for a policy to require all outdoor public places to be smokefree. To be marked Yes, the policy should include a provision stipulating that all outdoor public places must be 100% smokefree. The provision may have language to the effect of "public outdoor places including but not limited to..." and does not include exemptions. If there is reluctance to mark any of the specific outdoor venue/location questions below with less than maximum credit (e.g.</p>

<b>Coder instructions</b>	<p>If <b>Q8 = Limited Smoking Areas</b>, provide details about the requirements.</p> <p><b>Note:</b> Two examples in jurisdictions that qualify for this limited exemption are upon approval of an application based on X criteria, and creating designated smokers' outpost(s).</p>

<b>Item</b>	<b>9. Does the policy require any outdoor dining areas (i.e. restaurants) to be smokefree?</b>

<b>Coder instructions</b>	<p><b>All</b> = The policy requires outdoor dining areas of restaurants to be smokefree.</p> <p><b>Some/Sections</b> = The policy requires outdoor restaurant dining areas to have a nonsmoking section, but they are not required to be totally smokefree, or only some outdoor restaurant dining areas are covered by the policy.</p> <p><b>No</b> = The policy does not restrict smoking in outdoor restaurant dining areas.</p> <p><b>Note:</b> Some policies allow smoking in outdoor dining areas, but not within so many feet of entrances, etc. to the restaurant, thus implying that there could be a nonsmoking section within the specified distance from the entrances. However, unless there is such a specific requirement, this field is marked "No," because restaurants could simply place all outdoor seating beyond the specified distance. This field is also marked "No" if the policy only prohibits smoking in outdoor dining areas that encroach on sidewalks, parks, or other public spaces, because in such cases smoking is not prohibited in outdoor dining areas within privately owned parts of restaurants.</p>

<b>Coder instructions</b>	<p><b>All</b> = The policy requires outdoor bar areas to be smokefree.</p> <p><b>Some/Sections</b> = The policy requires outdoor bar areas to have a nonsmoking section, but they are not required to be totally smokefree, or only some outdoor bar areas are covered by the policy.</p> <p><b>No</b> = The policy does not restrict smoking in outdoor bar areas.</p> <p><b>Note:</b> Some policies allow smoking in outdoor bar patios, but not within so many feet of entrances, etc. to the bar, thus implying that there could be a nonsmoking section within the specified distance from the entrances. However, unless there is such a specific requirement, this field is marked “No,” because bars could simply place all outdoor seating beyond the specified distance. This field is also marked “No” if the policy only prohibits smoking in outdoor bar patios that encroach on sidewalks, parks, or other public spaces, because in such cases smoking is not prohibited in outdoor bar patios within privately owned parts of bars.</p>

<b>Coder instructions</b>	<p><b>Yes, both smoking and vaping marijuana</b> = The policy restricts both smoking and vaping marijuana to the same extent as smoking generally.</p> <p><b>Yes, marijuana smoking only</b> = The policy restricts smoking marijuana to the same extent as smoking generally..</p> <p><b>Yes, marijuana vaping only</b> = The policy restricts vaping marijuana to the same extent as smoking generally..</p> <p><b>No</b> = The policy restricts marijuana use to a lesser extent than smoking generally.</p>

See Q11b for details.</p> <p><b>No</b> = The policy does not restrict smoking in outdoor areas near buildings in which smoking is prohibited.</p>
