



# Matrix of Smokefree Outdoor Air Policies in California

October 2024

California communities have been enacting local smokefree air protections for outdoor public places and workplaces for several decades. Cities and counties have responded to demand for reducing secondhand smoke exposure in outdoor areas of restaurants, bars, and other worksites, as well as numerous types of outdoor gathering spaces including recreational areas, public events, and transit stops.

Jurisdictions qualify for this Smokefree Outdoor Air matrix if they regulate smoking in **1 or more** of the seven types of outdoor venues listed below.

**Note:** This matrix includes **both** policies that are on the PETS website, which is current through March 31, 2021, **and** more recently enacted and analyzed policies that are not yet in the PETS database. Jurisdictions with new or updated policy provisions on this matrix, but not yet on PETS, are denoted by ~. The matrix does not include policies that have not yet been analyzed by ANRF staff.

Currently, **405** California municipalities in **53** counties (56 LLAs) have enacted policies that regulate smoking in **1 or more** of the following outdoor public places:

- 156 municipalities prohibit smoking in all Outdoor Dining Areas. Another 29 municipalities prohibit smoking in some areas/sections.
- 117 municipalities prohibit smoking in all Outdoor Bar Areas. Another 21 municipalities prohibit smoking in some areas/sections.
- 29 municipalities prohibit smoking in all Outdoor Public Events & Venues. Another 121 municipalities prohibit smoking in some or specified types of Outdoor Public Events & Venues, and 43 municipalities prohibit smoking in sections. Outdoor Public Events & Venues may include farmers' markets, fairs, concerts, flea markets, sports arenas, swap meets, shopping centers, special/specified events, etc.
- 77 municipalities prohibit smoking in all Outdoor Recreational Areas. Another 249 municipalities prohibit smoking in all municipal, or some or specified types of Outdoor Recreational Areas, and 63 municipalities prohibit smoking in sections. Outdoor Recreational Areas may include parks, playgrounds, trails, bike/pedestrian paths, sports fields, beaches, etc.
- **131** municipalities prohibit smoking in **all Outdoor Transit Stops/Shelters**. Another 18 municipalities prohibit smoking in some or specified Outdoor Transit Stops/Shelters.

- 26 municipalities prohibit smoking in all Outdoor Public Easements/Rights of Way. Another 143 municipalities prohibit smoking in some or specified types of Outdoor Public Easements/Rights of Way, and 20 municipalities prohibit smoking in sections. Outdoor Public Easements/Rights of Way may include sidewalks, plazas, downtown/business districts, service lines, etc.
- **53** municipalities prohibit smoking in **all Outdoor Places of Employment**. Another 5 municipalities prohibit smoking in all private Outdoor Places of Employment, and 15 prohibit smoking in some Outdoor Places of Employment. Outdoor Places of Employment may include construction areas, farm fields, etc.

Smokefree outdoor air policies have been enacted by **75%** of California jurisdictions (405 of the 540 total cities and counties) and **34,828,522** Californians, or **88.5%** of the state population, live in these jurisdictions.

**ESDs and Marijuana:** PETS policies are analyzed to determine if the use of electronic smoking devices (ESDs) and marijuana smoking and/or vaping are regulated in the same manner as tobacco smoking. The majority of the jurisdictions on this outdoor secondhand smoke matrix prohibit both ESD use and smoking/vaping of marijuana wherever tobacco smoking is prohibited. PETS users can look up the specific ESD and marijuana coverage for each individual outdoor policy provision on the PETS <u>Secondhand Smoke</u> page.

## Definitions:

**Most Recent Enactment Date:** Jurisdictions may have enacted multiple policies addressing smoking in outdoor spaces, such as amending prior policy provisions. The matrix lists the most recent date that a policy addressing smoking in the outdoor spaces covered by this matrix was enacted or amended.

## **Outdoor Dining Areas:**

All = Policy requires all outdoor dining areas of restaurants to be smokefree.

Some/Sections = Policy requires outdoor dining areas of restaurants to have a nonsmoking section but are not required to be totally smokefree, or only requires some outdoor restaurant dining areas to be smokefree.

#### **Outdoor Bar Areas:**

All = Policy requires all outdoor areas of bars to be smokefree.

Some/Sections = Policy requires some or sections of outdoor bar areas to be smokefree. Policy requires outdoor areas of bars to have a nonsmoking section but are not required to be totally smokefree, or only requires some outdoor bar areas to be smokefree.

#### **Outdoor Public Events & Venues:**

Examples of outdoor public events & venues include farmers' markets, fairs, concerts, flea markets, sports arenas, swap meets, shopping centers, special/specified events, or other specified spaces.

All = Policy requires all outdoor public events & venues to be smokefree. Policy is typically written as including "all but not limited to..." with a sampling of such events/venues listed.

Some/Specified = Policy requires some events & venues, or specified events & venues, or city/county-sponsored events, and/or city/county-owned venues to be smokefree.

Sections = Policy requires outdoor events and/or venues to be smokefree except for designated smoking areas.

## **Outdoor Recreational Areas:**

Examples of outdoor recreational areas include parks, playgrounds, trails, bike/pedestrian paths, sports fields, beaches, or other specified spaces.

All = Policy requires all outdoor recreational areas to be smokefree. Policy is typically written as including "all but not limited to..." with a sampling of such areas listed.

City/County/Some = Policy requires all municipal outdoor recreational areas to be smokefree, or some outdoor recreational areas, or specified outdoor recreational areas.

Sections = Policy requires outdoor recreational areas to be smokefree except for designated smoking areas.

## **Outdoor Transit Stops/Shelters:**

All = Policy requires all outdoor transit waiting areas, such as stops and/or shelters, to be smokefree.

Some = Policy requires some outdoor transit waiting areas to be smokefree, such as stops for specified transit systems, or transit shelters must be smokefree but the policy is silent on stops.

## **Outdoor Public Easements/Rights of Way:**

Examples of outdoor public easements/rights of way include sidewalks, plazas, downtown/business district(s), service lines, or other specified spaces.

All = Policy requires all outdoor public easements/rights of way to be smokefree. Policy is typically written as including "all but not limited to..." with a sampling of such spaces listed.

Some = Policy requires some or specified public easements/rights of way to be smokefree.

Sections = Policy requires public easements/rights of way to be smokefree except for designated smoking areas.

# **Outdoor Places of Employment:**

Examples of outdoor places of employment include public and/or private worksites, including construction areas, farm fields, or other specified worksites.

All = Policy requires all public and private outdoor places of employment with 2 or more workers to be smokefree.

Private worksites = Policy requires all private outdoor worksites to be smokefree, but does not cover municipal outdoor worksites.

Partial = Policy requires specific outdoor worksites to be smokefree.
