



Matrix of Policies Regulating the Sale of Flavored Tobacco Products in California

October 2024

This matrix provides an overview of key policy provisions in the municipalities that have enacted ordinances that regulate the sale of flavored tobacco products. California cities and counties have led the way in adopting policies that regulate the sale of flavored tobacco products. California can boast the first municipalities in the U.S. to end the sale of all flavored tobacco products—including menthol—at all retailers.

The purpose of these policies is to reduce access to the flavored tobacco products that are enticing young people to start on a lifetime of nicotine addiction, to limit the negative public health consequences of tobacco use, and to reduce the impact of targeted tobacco industry marketing of menthol cigarettes especially to communities of color and low-income communities.

Note: This matrix includes **both** policies that are on the PETS website at <https://pets.tcpspartners.org>, which is current through March 31, 2021, **and** more recently enacted and analyzed policies that are not yet in the PETS database. Jurisdictions with new or updated policy provisions on this matrix that are not yet on PETS are denoted by ~. The matrix does not include policies that have not yet undergone PETS analysis.

Currently, **140** California municipalities in 28 counties have enacted policies that have been analyzed and regulate the sale of flavored tobacco products in some manner:

- **81** municipalities prohibit the sale of all flavors of all tobacco products, **including menthol**, at all venues. These communities are in **bold**.
- **106** municipalities prohibit the sale of **menthol cigarettes** in all venues.
- **122** municipalities fully or partially prohibit the sale of **menthol cigarettes**, regardless of any other exemptions.

~ **Not in PETS:** Municipalities marked with ~ have new or updated policy provisions that are not yet reflected in the PETS database.

In California, county Boards of Supervisors have the authority to pass policies for the unincorporated areas of the county, and these policies generally do not apply to incorporated cities/towns located within the county. Thus, the matrix lists the population of the unincorporated area of each county.

N/A*: Manhattan Beach prohibits the sale of all tobacco and nicotine products (non-nicotine ESDs are not regulated, per chapter definitions), and no longer issues tobacco retailer licenses.

** San Benito County's policy covers the cities of Hollister and San Juan Bautista.

ANRF is aware of additional flavored tobacco policies enacted in jurisdictions, and they will be added to the matrix once the policies have undergone PETS analysis.

Moratorium policies: Jurisdictions, such as Santa Clarita, that have enacted a moratorium on flavored tobacco sales are not included on this document. For PETS purposes, a moratorium is not considered to be equivalent to a law since these policies are temporary.

Repealed policies: Jurisdictions that enacted flavored tobacco policies and later repealed them are not included on this document. Delano enacted two flavored tobacco policies on 11/18/2019 and 3/16/2020 and later repealed them both on 11/16/2020.

Definitions:

ESDs = Electronic smoking devices, such as e-cigarettes, hookah pens, e-liquids, and other vaping products.

Most Recent Enactment Date: Jurisdictions may have enacted multiple policies regulating flavored tobacco products, such as amending prior policy provisions. The matrix lists the most recent date that a policy regulating flavored tobacco products covered by this matrix was enacted or amended.

TRL Required: This column addresses whether the jurisdiction requires a local tobacco retailer license (TRL) but does not specify whether the flavored tobacco restrictions are specifically included in the TRL framework.

Yes = Policy requires merchants to obtain a local tobacco retail license (TRL) to sell tobacco products.

Partial = Policy requires some but not all merchants to obtain a local tobacco retail license (TRL) to sell tobacco products.

¹ **Includes Menthol Products:** This column addresses whether the policy regulates the sale of menthol-flavored tobacco leaf products (e.g. cigarettes, cigarillos/little cigars, cigars, snuff, chew, snus, heated products, shisha/hookah). This column does not address ESDs.

Yes, all = Policy prohibits the sale of all menthol flavored tobacco leaf products.

Yes, some = Policy prohibits the sale of some, but not all, menthol flavored tobacco leaf products.

Yes, except at certain locations = Policy prohibits the sale of menthol flavored tobacco leaf products except at certain specified locations, such as adult-only, specialty tobacco retailers, and/or tobacco bars.

² **Includes Combustibles:** This column addresses whether the policy regulates the sale of non-menthol flavored combustible tobacco products (e.g. cigarillos/little cigars, cigars, hookah/shisha tobacco, pipe tobacco, etc.). The policy may regulate the sale of some, but not all, types of combustible products.

Yes, all = Policy prohibits the sale of all non-menthol flavored combustible tobacco products.

Yes, some = Policy prohibits the sale of some, but not all, non-menthol flavored combustible tobacco products, such as flavored hookah/shisha tobacco or flavored premium cigars.

Yes, except at certain locations = Policy prohibits the sale of all non-menthol flavored combustible tobacco products except at certain specified locations, such as adult-only, specialty tobacco retailers, and/or tobacco bars.

³ **Includes Non-Combustibles:** This column addresses whether the policy regulates the sale of non-menthol flavored non-combustible tobacco products (e.g. snus, snuff, chew, etc.)

Yes, all = Policy prohibits the sale of all non-menthol flavored non-combustible tobacco products.

Yes, some = Policy prohibits the sale of some, but not all, non-menthol flavored non-combustible tobacco products.

Yes, except at certain locations = Policy prohibits the sale of all non-menthol flavored non-combustible tobacco products except at certain specified locations, such as adult-only, specialty tobacco retailers, and/or tobacco bars.

⁴ **Includes ESDs:** This column addresses whether the policy regulates the sale of flavored ESDs.

Yes = Policy prohibits the sale of all flavors of ESDs.

Yes, except menthol = Policy prohibits the sale of all flavors of ESDs except sale of menthol-flavored ESDs is permitted.

Yes, except ESDs w/o nicotine = Policy does not apply to flavored ESD products that do not contain nicotine.

Yes, except at certain locations = Policy prohibits the sale of all flavors of ESDs except at certain specified locations, such as adult-only, specialty tobacco retailers, and/or tobacco bars.

Yes, except with FDA premarket review order = Policy prohibits the sale of all flavors of ESDs except for products that have been authorized for sale under the FDA's premarket review process.
